



## Membership Categories

Effective April 1, 2022

**Full Family Membership-** This membership allows both spouses, and all children younger than 19 years old full access to all club amenities. This includes two commuter parking stickers.

Monthly Dues: \$495  
Monthly Food Minimum: \$125  
Monthly Dining Surcharge: \$40

Non-Refundable Initiation Fee Options (first payment made prior to membership activation):

**Option 1: \$7,000 (plus NJ State Sales Tax)** paid in full;

**Option 2: \$8,000** paid in 2 installments of \$4,000 (plus tax) in years 1 and 2;

**Option 3: \$9,000** Preview Membership paid \$3,000 (plus tax) initially. On your one year anniversary you can a) continue your membership for a \$6000 (plus tax) fee or b) resign at no additional cost;

**Option 4 (Temporary Residents only): \$10,000** paid in 5 installments of \$2,000 (plus tax) for 5 years (future installments can **only** be terminated if moving > 50 miles away)

**Senior Family Membership-** This membership requires 10 years of consecutive membership OR 5 years of consecutive membership with your youngest child being at least 15 years of age or your oldest being at least 17 years of age. It allows the same privileges as full membership to both spouses and all children under age 19. This includes commuter parking.

Monthly Dues: \$360 \* Monthly Dining Surcharge: \$40  
Monthly Food Minimum: \$125

**Social Membership (non-equity)-** This membership requires 10 years of consecutive membership OR 5 years of consecutive membership with your youngest child being at least 15 years of age or your oldest child being at least 17 years of age. This DOES NOT include commuter parking or golf privileges.

Option A -Social with Pool: It **excludes** any paddle or tennis related events, lessons or usage of courts. Immediate family members are permitted to dine with the member for a la carte dining in the Hobart Grill, attend club events or dine at the Poolside Café. It includes pool usage.

Option B - Social with Racquets: It **excludes** usage of the pool facility. Only the account holder may attend racquets related events, take lessons or be entitled to court usage. Immediate family members are permitted to dine with the Single member for a la carte dining in the Hobart Grill, attend club events or dine at the Poolside Café.

Monthly dues \$250 \* Monthly Dining Surcharge: \$30  
Monthly food minimum: \$95

**Racquets Single Membership-** This membership requires 5 years of consecutive membership. Only the account holder may utilize club amenities. No pool usage is included in this package. Immediate family members are permitted to dine with member. This class is being replaced with Social Membership B and is no longer available. Those currently in it will be grandfathered.

Monthly Dues: \$250.  
Monthly Food Minimum: \$95  
Monthly Dining Surcharge: \$30
